Truth in Taxation Hearing
August 6, 2025

The Board of Education of Weber School District held a Board Meeting in the Board Rooms at 5320 Adams Avenue Parkway, Washington Terrace, Utah. The meeting convened at 7:00 p.m.

AGENDUM ITEM #1 – Presentation on Proposed 2025 Tax Rate

Business Administrator Brock Mitchell presented to those in attendance and explained he wants to educate everyone on how school funding works. He began explaining how tax notices work and the market value on homes which is currently \$524,000 for the average home in Weber County. It was noted on June 1st we are required as an entity to set the maximum amount and at that time was 21%. That does not necessarily mean the recommendation to the Board. The Board voted and capital make up the certified rate. Our recommendation is to increase 4 tax increments above the certified rate to 18.2 to help maximize the state guaranteed funding of the Board and Voted levy. This results in a 5.64% tax increase compared to the 2024 rate and an additional \$9,722,950 for the district.

Bond Status was explained noting this is not being presented for the new schools. This was completed with no tax increase. Due to inflation we moved to a Lease Revenue Bond in conjunction of lowering the Debt Service Levy. Cost comparison was shared from 2016 to 2025 showing a 162% increase. The repayment of the Lease Revenue Bond is already built into our budget and not part of the truth in taxation changes.

The different levies were explained noting the State Basic Levy is set by the legislature each year and districts have no control. Charter School is imposed to help fund charter schools who enroll students living within the district's boundaries. Debt Service/GO Levy is utilized to repay voter approved bonds over a determined period. Board/Voted Local Levy is set by the

School Board to help fund essential school operations. Capital Levy is also set by the School Board for capital needs. District Certified Rate is the sum of Board, Voted and Capital Levy.

Property taxes and revenue neutrality was explained noting property taxes are set each year to ensure entities receive equal revenue to the previous year, plus revenue from new growth. When assessed values increase, certified rates automatically decrease and create an inverse relationship.

Hold Harmless was explained is the reason why the district had to make some decisions. In the past, the legislature had a six year hold harmless rate. The last legislative session HB2 made a change from a six year to a two-year period. This requires district to look at hold harmless calculations every year. The legislature did implement a three-year step-down to help districts move toward the full 20 tax increments allowed by the state formula.

State Guarantee funding is designed to equalize education funding for all students across the state, regardless of the property values. To maximize the guaranteed funding, the expectation is for districts to levy their tax increments up to 20. WPU reduction due to legislative change resulted in loss of Professional Staff in the WPU calculation.

District rate comparisons were shared from FY24 to FY25 and show Weber School District is at the bottom in relation to other districts throughout the state.

In conclusion it is recommended the Board set the local levy to 0.000844, voted local 0.000900 and overall tax rate 0.005792. It will raise an additional \$9,722,950 to help maintain existing operational status with a yearly change to homeowners of \$46.83 and a monthly change of \$3.90.

Mr. Mitchell concluded his presentation and turned the time over to President Paul Widdison.

AGENDUM ITEM #2 – Public Hearing

President Widdison called for a motion to open the Public Hearing.

President Widdison explained the process for the public hearing. It was noted those wishing to address the Board will have a three-minute time limit.

AGENDUM ITEM #3 – Discussion/Action Items

A. Approval of 2025 Tax Rate for Weber School District

Superintendent Butters expressed thanks for all those who participated tonight. She explained her job is to represent the children in Weber School District and shared that over time, the Board has worked hard to keep property tax rates low. They have stretched dollars and maintenance needs that affect the safety of schools and quality of instruction, and if we fail to meet the minimum local effort required by the state, will forfeit funding over time. We face non-negotiable state mandates and need a pause on legislative mandates. Of 582 bills last legislative session, 154 directly impact public education in some way. Many of the mandates are not funded and funding is going toward school vouchers.

Business Administrator Brock Mitchell gave the final recommendation of a net increase of 4 to 18.2 tax increments, with a Board Levy of 0.000844 and Voted Levy of 0.0009 resulting in a 5.64% tax increase for the average household a \$3.90 increase per month.

President Widdison opened it up to the Board for comments.

Board Member Janis Christensen expressed she is conflicted and appreciates everyone who has expressed their thoughts and thanked everyone. She noted she would agree to a 5% increase.

Board Member Jan Burrell also expressed appreciation for everyone being here tonight. She explained that 26% of students in the county are under the age of 18 and have no vote and believes students should have the best education possible. She also encouraged everyone to attend Board meetings more often.

Board Member Kelly Larson also thanked everyone and would like people to attend Board meeting more often and also volunteer in classes. She explained she recognizes the tax burden on families and explained she has done a lot of research.

Board Member Wyle Williams explained he is learning the processes and thanked everyone for their comments. He has observed while on the Board the district is fiscally responsible. This is about needs not wants. If we don't do something about raising the basic tax levy now, next year will be worse.

Board Member Bruce Jardine thanked all those who came and are involved and noted they have been heard. He asked everyone to take a closer look at the presentation that was shared tonight. Our inability to act would be a great crime in his opinion.

Board Vice President Doug Hurst thanked everyone and noted it is great to live in America. He noted he is on the Capital Improvement Committee and is concerned about school safety. The bonding agencies look at the equity balances of districts for the interest rates. He concluded it's all about the kids and he will vote yes in support of the tax increase.

President Widdison noted if anyone has questions, please reach out to Business Administrator Brock Mitchell for a better understanding.

President Widdison called for a motion to approve the 2025 Tax Rate for Weber School District.

That the 2025 Tax Rate for Weber School District be approved. Voting was 6 to 1 in favor of the motion.

After determining no further business need be conducted, President Widdison called for a motion to adjourn the Truth in Taxation Hearing.
