A RESOLUTION OF THE DRAPER CITY COUNCIL CERTIFYING  
THE OFFICIAL CANVASS OF THE MUNICIPAL PRIMARY  
ELECTION RESULTS HELD ON AUGUST 12, 2025

**WHEREAS**, on August 12, 2025, Draper City conducted a Municipal Primary Election for one At-Large City Council seat for a two-year term; and

**WHEREAS**, pursuant to Utah Code Annotated § 20A-4-301, the Draper City Council, acting as the Board of Canvassers, has reviewed the election returns for the 2025 Municipal Primary Election held on August 12, 2025; and

**WHEREAS**, Utah Code § 20A-4-304 requires the Board of Canvassers to declare as “nominated” those candidates who received the highest number of votes within the jurisdiction and to certify the official election results; and

**WHEREAS**, the Election Officer has submitted an election report to the Board of Canvassers containing the vote totals, ballot reconciliation, and other information required by law, which the Board of Canvassers has examined and approved;

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CANVASSERS OF DRAPER CITY, STATE OF UTAH, AS FOLLOWS:**

**Section 1. Canvass and Certification.** The Board of Canvassers hereby accepts, declares, and certifies the results of the Draper City Municipal Primary Election held on August 12, 2025, as set forth in Exhibit A, as the official canvass results.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon its passage.
