

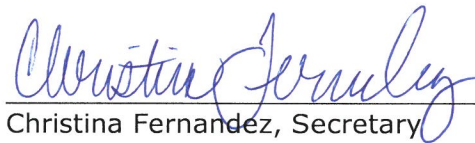

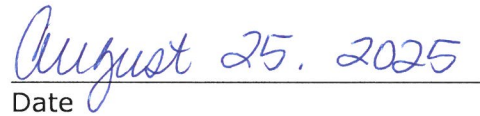
**Public Notice**
