Proposed change to the Personnel Policy and Procedures Manual

Current Wording

10. HOURS WORKED BONUS. To better ensure the uninterrupted completion of a minimum of 8 hours field work per week throughout the full duration of the mosquito season, a bonus payment of \$1.50 (one dollar and fifty cents) per hour for all hours cumulatively worked for the entire season will be awarded to each seasonal employee, at season' end, on the condition that the minimum of 8 hours work per all weeks had, without exception, been satisfactorily accomplished by the employee. If for any reason the above condition were not met, the employee would be ineligible for, and thus not receive said payment.

Proposed Change

10. Hours Worked Bonus Period Policy

Objective

To encourage consistent fieldwork in the form of larviciding activities throughout the entire mosquito season.

Eligibility

Seasonal employees are eligible for a bonus of \$1.50 per hour for all hours worked during the bonus period. This bonus will be paid at the end of the season.

Conditions

- A. The District Director will determine the official starting and ending dates of the bonus period each year. Dates may vary year to year.
- B. To receive the bonus, an employee must have satisfactorily completed a minimum of 8 hours of larviciding related activities every week of the bonus period.
- C. If an employee fails to meet this weekly requirement for any reason, they will not be eligible to receive the bonus payment.

Exceptions

- A. An employee hired after the official start date of the bonus period can still qualify for the bonus, provided they work a minimum of 8 hours of larviciding activities every week for the remainder of the bonus period.
- B. If an employee knows at the time of hire that their termination date will be before the bonus period's end date, they may still qualify. This is contingent on the termination date being approved in writing, with an explanation signed by the District Director or a designee. The employee must also work a minimum of 8 hours of larviciding activities every week for the duration of their agreed-upon bonus period. Strict discretion should be used to maintain the purpose of the bonus.
