## **BOARD REPORTS**

Commissioner Tebbs reported on his ongoing work with the Panguitch Lake Fire District. He shared that he had received several compliments regarding the County Fair and that the participants of the livestock show were pleased with the results of the livestock sale. He expressed his concern about the drought conditions currently affecting the area.

Commissioner Taylor also expressed his concerns regarding the drought. He thanks all those who contributed to the success of the fair. He reported that the Hospital Foundation dinner is scheduled for Friday evening. He will be attending the Five County AOG Board Meeting this week. He announced that the Calf Creek Project has been cancelled for this year, with plans to complete phases two and three next year. Commissioner Taylor also provided updates on the Transient Room Tax in local communities. He shared information regarding the Antimony Post Office.

Commissioner Pollock reported on the status of current local fires. He plans to meet with the state engineer to discuss Tropic Reservoir storage. He is actively working to resolve various public land issues. He reported on the significant challenges ranchers and farmers are facing due to the severity of the ongoing drought.

#### **PUBLIC WORK BUSINESS**
