**A RESOLUTION AUTHORIZING MANTUA TO ENTER INTO
AN INTERLOCAL AGREEMENT WITH BRIGHAM CITY
TO USE BRIGHAM CITY'S WASTEWATER SERVICES FOR
MANTUA'S DISCHARGE OF WASTEWATER**

WHEREAS, Mantua is a municipal corporation duly incorporated pursuant to the laws of the state of Utah, and

WHEREAS, Mantua recognizes and uses Brigham City as the provider of the wastewater treatment services for its residents pursuant to an agreement that has benefited both Brigham and Mantua for many years, but which Brigham City has deemed expired.

WHEREAS, Mantua understands that Brigham City is willing to continue taking Mantua's wastewater under this new mutual agreement and Mantua commits to deliver its wastewater to Brigham City as defined in the agreement.

WHEREAS, Mantua recognizes the significant laws, rules, and regulations that Mantua must adhere to and further recognizes that the provision of this service must be closely monitored and carefully reviewed continually not only to assure compliance but to ascertain that Mantua's flows fall in the proscribed limits and if their flows exceed those limits additional fees will be assessed; and Mantua will continue to identify and correct problems with the system.

WHEREAS, Mantua and Brigham recognize that close coordination and cooperation is necessary for this important essential service to be delivered successfully to Mantua's residents; and

WHEREAS, Mantua desires to provide its wastewater to Brigham City and Brigham City desires to receive Mantua's wastewater subject to the terms of this Agreement; and

WHEREAS, the Parties are authorized by the Utah Interlocal Cooperation Act, as set forth in Title 11, Chapter 13, Utah Code Annotated (UCA) 1953, as amended, to enter into this Agreement.




The foregoing recitals are incorporated herein.
