J-U-B ENGINEERING-MAIN STREET PROJECT UPDATE

Mayor Cooper stated that Chris Thomson from J-U-B was here to give an update on the Main Street Water Project and about the meeting with Andrew Orlando who is an architectural engineer who came and talked with us about the parks to see about getting a grant to improve the parks. Chris Thomson stated that on the water project, they still have a few connections to make but they are getting pretty close to the completion of the project, they have been really happy with the work Patriot Precision is doing. They have run into a lot of challenges with the system itself; they have worked through the problems very well. They are about three weeks from finishing the water project and 3 months on the street project was his understanding. He then said he wanted to thank the council for serving on the board he knows in previous years the mayor had a hard time filling those seats, he also wanted to thank the staff and the mayor for all their hard work, especially over these last few weeks. He knows we have had some issues with staff, and he hopes they will do what best for the city and that people make mistakes and everyone deserves a second chance, that we have a really good team working in Myton right now. He also mentioned the challenges we may run into when trying to hire another staff. Herald Crapo asked if new meters were being installed along Main Street and if they would be done in 3 or so weeks. Chris Thomson replied he thinks they will be done within that time. Chris Thomson stated that the engineer that came and looked at the parks are really good at locating funding for those kinds of projects and he will present some design and funding options. Carrie Boren stated that the water will be shut off for four days the last weeks of July from 8am to 5pm. She said they are sending fliers in the mail and placing door knockers to inform the residents. The Legion Hall will be open for a cooling center and there will be porta potties there also.

CITY DEPARTMENTAL REPORTS ON LAST MONTH'S ACTIVITIES

Mayor Cooper: Mayor Cooper stated that she is looking for someone who can repair the dunk tank, it can't be used. We had a couple of accidents during Myton Daze, it needs to be welded and needs a top made and she is looking for someone to paint the sign in front of city hall.

Carrie Boren: Carrie Boren stated that there has been a lot of talk and questions about her role in the election process, so she printed the Utah state code and the responsibilities and roles of the city clerk when it comes to elections. That way if others had questions, they would have the answers. She also stated she had Wes from Johson Water here with us because he has been overseeing the water system and in case they had any questions for him. Carrie Boren also stated that we will need 3 poll workers for the primary election in August.

Wes Hanberg stated that he knows there has been some animosity in the past with Myton City Nad Johnson water he read it in the book about Myton. He asked if that was the case still. Mayor Cooper replied that it happened many years ago and we good to go. Wes Hanberg introduced who he was, he has been working with water for 13 years. Johnson Water is aware of the situation, and they are here to help.
