4. Consideration of ORDINANCE NO. 2025-04 FINALIZING THE ADOPTION OF A TAX LEVY PURSUANT TO SECTION 10-5-112 OF THE UTAH CODE ON REAL AND PERSONAL PROPERTY WITHIN THE TOWN OF DUTCH JOHN, UTAH MADE TAXABLE BY LAW FOR FISCAL YEAR 2025-2026 WITH COMPLETION OF THE REQUIREMENTS UNDER SECTION 59-2-919 OF THE UTAH CODE - Discussion and Possible Action

Minutes:

- Harriet started by making a motion to accept the adoption of a tax levy for the Town. Amy second.
- The motion was followed by a discussion. During deliberations, many council members expressed being torn between the personal financial burden of new

taxes and the need for long-term stability and growth of Dutch John.

- Sandy felt that not all other funding sources had been fully explored. She warned that additional taxation could change Dutch John's character, making it more like Jackson Hole, which she does not want.
- Harriet acknowledged it was a good discussion but supported passing the measure.
- Al expressed mixed feelings—recognizing the burden on homeowners but also understanding the town council's perspective and the need for reliable funding.
- Amy questioned whether the full \$100k proposed was necessary, suggesting a reduced amount might be a more manageable middle ground. She noted the difficulty of balancing fairness for current homeowners with the town's needs.
- Al (follow-up) emphasized that lowering the rate would not generate enough revenue to achieve the mayor's goals. He also raised the possibility of relying more on transient sales tax, other sales taxes, and RDA funds.
- Mayor Butch stressed that while grants and sales taxes can supplement revenue, property tax provides a stable base income—and in some cases is required to qualify for additional funding.
- In the end, the majority of council members voted in favor of the measure, prioritizing the town's long-term ability to fund services despite concerns about the financial impact on residents.
