Approval of Resolution 251-2025 Ashlee Larsen stated Mayor Maxwell has requested that a moratorium resolution be placed on the agenda. This resolution would address living in hotels and motels on Main Street and State Street.

The mayor's intention is for Planning and Zoning to develop and implement an ordinance regarding this matter. The moratorium resolution would remain in effect until the new ordinance is formally in place. **Randy Christiansen** inquired about the hotels and motels where residents are currently living. **Kevin Mickelsen** mentioned that some of these residences are grandfathered. Salina City needs to investigate zone change. **Ashlee Larsen** stated a couple of years ago, the council discussed that hotels and motels on Main Street should have their own kitchenettes and power boxes to be livable. Council members discussed hotel/motels currently occupied and their concerns about parking issues. Kevin Mickelsen asked if the Moratorium is only for 45 days. **Brock Jackson** stated Salina City can do a moratorium for 180 days if the ordinance is completed by that date.

Kevin Mickelsen motioned to approve Resolution 251 2025 with a moratorium of 180 days. **Randy Christiansen** seconded. Motion carried 4 to 0.

PEHP benefits: Ashlee Larsen stated this item isn't on the agenda regarding PEHP benefits. It requires a decision from City Council to determine whether Salina City will cover the new fiscal year amount for employee PEHP benefits or if employees will be responsible for paying the difference.
