EXECUTIVE SECRETARY REPORT

Mr. Mackey addressed the Board with the following updates:

- Mr. Mackey explained to the Board that the EPA has recently published a draft guidance on the
 implementation of the Supreme Court decision on Maui, regarding Maui versus Hawaii Wildlife
 Fund. Mr. Mackey noted that this has been a challenge for us. Maui addresses what's called
 functional equivalent of a discharge and in this case, Maui used a deep well injection for disposal
 of treated effluent. You may hear Mr. Mackey's full explanation on the meeting recording at June

- Mr. Mackey wanted to touch base on the President's proposed budget. He said the thing that is most important for the Board is the current proposal. The skinny budget would include a 90% cut to SRF Funds and so what does that mean? If that were to be the end, it would be our annual Cap Grant would be reduced to about 1.4 million dollars per year and in terms of the amount of money that the Board has to put out and annual Cap. The Grant represents about a 3rd so effectively, we'd lose a 3rd of our budget so roughly depends on year to year. We'd have 20 million dollars a year to invest in loan funds instead of 30 million. There's of course lots of proposed changes, reductions in budgets for EPA funding and another important one to us and to permit east is what's called the CDX Exchange Network. This is a data management system that we use for a lot of things. For transporting information in large amounts. • Mr. Mackey discussed that HAB Season is now upon us. Harmful Algal Blooms. We are seeing warning level concentration in some of the waters around the State. The trajectory for the next week or so is increasing temperatures. We have some holidays coming up with more recreation and so we have our monitoring crews out collecting samples and we have had some significant hits on both cell counts and toxic concentrations, Cyanotoxin concentrations.
