

AN ORDINANCE OF THE CITY COUNCIL OF LAVERKIN, UTAH, APPROVING AN INCREASE IN COMPENSATION FOR THE LAVERKIN CITY RECORDER AND LAVERKIN CITY RECREATION DIRECTOR, AND ESTABLISHING EFFECTIVE DATE

WHEREAS, pursuant to Utah Code § 10-3-818, the City Council of the City of LaVerkin is authorized to fix the compensation of elective and statutory officers by ordinance adopted after public hearing; and

WHEREAS, the City Recorder is a statutory officer under Utah law, and the City Recreation Director is an executive officer as defined in § 10-3-818(2); and

WHEREAS, the City Council has determined that an increase in compensation for each office is appropriate and in the public interest; and

WHEREAS, a public hearing was held on August 20, 2025, in accordance with statutory requirements to receive public input on the proposed compensation increase;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAVERKIN, UTAH:

SECTION 1. COMPENSATION INCREASE APPROVED:

The annual compensation for the following officers is hereby increased as follows:

- Nancy Cline, City Recorder, from \$ 58,793.28 to \$ 63,793.28 per year.
- Maridee Johnson, City Recreation Director, from \$ 42,736.51 to \$ 47,736.51 per year.

This increase in compensation shall become effective on AUGUST 23 2025 and shall, subject to applicable withholdings and benefits, be payable in accordance with the City's regular payroll schedule and procedures.

SECTION 2. REPEALER:

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed to the extent of such conflict.


SECTION 3. SEVERABILITY:


SECTION 4. EFFECTIVE DATE:


