RESOLUTION APPROVING AN INTERLOCAL COOPERATION AGREEMENT WITH SALT LAKE COUNTY AND THE CITY OF WEST JORDAN REGARDING PROCESSING PRE-JULY 1, 2025 OQUIRRH HIGHLANDS DEVELOPMENT PERMIT APPLICATIONS, BONDS AND ASSOCIATED RECORDS

RESOLUTION NO. 2025-09-02

WHEREAS, the Greater Salt Lake Municipal Services District (the "MSD"), Salt Lake County (the "County"), and the City of West Jordan (the "City") are public agencies as defined in Title 11, Chapter 13 of the Utah Code (the "Interlocal Cooperation Act");

WHEREAS, Section 11-13-202 of the Interlocal Cooperation Act provides that any two or more public agencies may enter into an agreement for joint or cooperative action; and

WHEREAS, the County has jurisdiction over all unincorporated areas within the County;

WHEREAS, the MSD provides planning and development services for the County respecting unincorporated areas;

WHEREAS, on July 1, 2025, the land on which the Oquirrh Highlands Subdivision ("Oquirrh Highlands Development") sits was annexed by the City;

WHEREAS, various applications, bonds, and permits were submitted to the County and the MSD in association with the Oquirrh Highlands Development before July 1, 2025; and

WHEREAS, the MSD, the County and the City desire to enter into an Agreement to memorialize a cooperative process for processing and transferring pre-July 1, 2025 applications, bonds and permits for the Oquirrh Highlands Development as provided in the Agreement.

NOW, THEREFORE, be it resolved and enacted by the Board of Trustees of the Greater Salt Lake Municipal Services District as follows:

- 1. That the Interlocal Cooperation Agreement referenced in the foregoing recitals (the "Agreement"), a copy of which may be attached to this Resolution, be and is adopted and approved and that Marla Howard, General Manager of the MSD, be and is authorized and instructed to execute and deliver the Agreement on behalf of the District.
- 2. That the keeper of the MSD's records is authorized and instructed to keep an executed copy of the Agreement as part of the District's records.
- 3. That this Resolution has been placed on the agenda of an official meeting and this action has been taken by the MSD Board of Trustees during that meeting in compliance with the Utah Open and Public Meetings Act.
- 4. That this Resolution shall take effect immediately upon its passage with the effective date of the Agreement to be the date of completion of the following: (a) the approval of the Agreement by each party as provided in Utah Code Ann. § 11-13-202.5(1) and (2), (b) the submission of the Agreement to an attorney for each party who is authorized to represent said party for review as to proper form and compliance with applicable law, and (c) the filing of a signed original or copy of the Agreement with the keeper of records of each party, all as provided in the Agreement.
