

MINUTES OF THE CITY OF WEST JORDAN TRUTH IN TAXATION HEARING MEETING

1. CALL TO ORDER

Chair Whitelock called the meeting to order at 6:00 pm

2. PLEDGE OF ALLEGIANCE

Paul Jerome led participants in the Pledge of Allegiance

3. PUBLIC HEARINGS

a. Truth in Taxation Public Hearing

Administrative Services Director Danyce Steck presented on the proposed property tax rate increase. She explained that under State Code 59-2-919, property tax rates decrease as property values rise, keeping city revenue level. In 2024, the city collected \$20.8 million at a rate of .001428; in 2025, the certified rate dropped to .001289, yielding the same revenue.

The proposed adjustment is a 2.93% increase, resulting in about \$2 more annually for the average home compared to 2024 (\$392 vs. \$390). With debt retired, residents will still see an overall tax reduction. Steck emphasized that West Jordan receives only \$0.57 of every property tax dollar, with most funding going to other entities.

She outlined the need for the increase as inflationary costs, funding two additional police officers, one firefighter, two part-time community service officers, and a new concrete crew. She reviewed where property tax dollars go: primarily to police, fire, streets, and general government. Compared with neighboring cities, West Jordan remains among the lowest in property tax rates.

Administrative Services Director Steck also highlighted best practices: listening to the taxpayer, address service demands and inflation annually not every 5-7 years and maintaining long-term sustainability of on-going revenue. She outlined the independent process to maintain oversight through the Salt Lake County Assessor Office, Salt Lake County Auditor, State Auditor, and State Tax Commission.

It was noted that the Council must adopt the final tax rate and budget by September 1, with the next meeting scheduled for August 26.

Chair Whitelock opened the public hearing at 6:10 pm

Comments:

Rob Bennett, resident expressed support for the proposed tax increase, noting past concerns with transparency but appreciating the improved information this year. He said contributing \$2 more annually is reasonable if it helps fund police, firefighters, code enforcement, and a concrete crew, making the city safer. He encouraged the Council to feel confident in supporting the proposal.

Chair Whitelock closed the public hearing at 6:13 pm
