IV. Public Comment

She questioned who in the district monitors if students are staying within the State guidelines for not more than 20 hours per week. Danny commented that school Principals are responsible to monitor the 20-hour guideline. Marc Grow commented that he knows kids who are burned out with too much pressure to be involved in too many sports. As clarification, the 20-hour limit applies to each sport.

D. Declining Vaccination Rates Report Summary
KCSD has the lowest percentage of students who are vaccinated as compared to all 41 school districts in Utah.
