The Special Meeting convened at 12:00 PM.

**B. Administrative Action Item**

**1. Canvass of the 2025 Municipal Primary Election**

Town Clerk Aren Emerson introduced the item, explaining that the canvass represents the official tally of votes for an election. The Springdale Town Council serves as the Board of Municipal Canvassers, responsible for publicly reviewing the official summary results prepared by the Washington County Election Officer and certifying the number of votes cast for each candidate and ballot proposition, as required by Utah Code § 20A-4-301.

Ms. Emerson explained that, at the conclusion of the canvass, the Board of Canvassers would declare the results to be true and correct and attest to them by signing the Certification of Election document.

There were 381 active voters, with 246 votes cast, resulting in a 64.57% turnout. Fifteen ballots were not counted: two could not be cured, seven were returned past the deadline, and six were deemed undeliverable. In the Mayoral race, there were four undervotes, and in the Council race, there were 40 undervotes.

Based on these results, Ms. Emerson, in her capacity as Town Clerk and Election Official, declared Barbara Bruno and Pat Campbell as the top two vote earners for the Mayoral race in the August 12, 2025, Primary

Election. She also declared Randy Aton, Tom Kenaston, Noel Benson, and Jack Burns as the top four vote earners for the Town Council race. These six candidates will be certified as nominees for placement on the November 4, 2025, General Election ballot.

Kyla Topham made a motion that the Board of Canvassers approve and certify the results of the August 12, 2025, Primary Election for the Mayor and Council races. Barbara Bruno and Pat Campbell are the nominees for the Mayoral candidates to be on the November 4, 2025, General Election ballot. The nominees for the Council candidates to be placed on the November 4, 2025, General Election ballot will be Jack Burns, Randy Aton, Noel Benson, and Tom Kenaston. The motion was seconded by Randy Aton.




