

RESOLUTION NO. 2025-6

A RESOLUTION OF THE CITY COUNCIL OF CENTERFIELD CITY, SANPETE COUNTY, UTAH, CANCELLING THE MAYOR AND CITY COUNCIL MEMBER RACES IN THE NOVEMBER 4, 2025, MUNICIPAL GENERAL ELECTION AND DECLARING EACH UNOPPOSED CANDIDATE ELECTED TO OFFICE.

WHEREAS, Centerfield City conducts municipal elections in accordance with the laws of the State of Utah; and

WHEREAS, Utah Code Annotated § 20A-1-202 establishes the first Tuesday after the first Monday in November of each odd-numbered year as the date for conducting a municipal general election; and

WHEREAS, the deadlines for candidate filing and declaration of write-in candidacy have passed; and

WHEREAS, each municipal officer candidate for the offices of Mayor and City Council Member is unopposed; and

WHEREAS, Centerfield City will still hold an election on November 4, 2025, for Proposition #10, the Recreation, Arts, and Parks (RAP) Tax Reauthorization; and

WHEREAS, Utah Code Annotated § 20A-1-206 provides a process whereby the City may cancel municipal races in a general election when the foregoing conditions have occurred, and upon compliance with applicable law;

NOW, THEREFORE, BE IT RESOLVED by the City Council of Centerfield City, Utah:

1. The races for Mayor and City Council Member in the November 4, 2025, municipal general election are hereby cancelled.
2. Each unopposed candidate is declared elected to office, effective upon compliance with applicable law.
3. Centerfield City will proceed with the election for Proposition #10 RAP Tax Reauthorization as required.

The following unopposed candidates are hereby declared elected to office:

- **Sherry Louise Fraiser**, City Council Member

FULFILLMENT OF THE SECOND VACANCY

The second City Council Member vacancy, for which no candidate filed, shall be filled according to the provisions of Utah Code Annotated § 20A-1-510
