

**TOQUERVILLE CITY  
CITY COUNCIL MEETING MINUTES  
September 3<sup>rd</sup>, 2025, at 6:00 pm  
212 N. Toquer Blvd, Toquerville Utah**

**A. CALL TO ORDER:**

Mayor Sip called the meeting to order at 6:00 p.m. Councilman Olsen led the Pledge of Allegiance. Invocation was led by Councilman Chaves.

1. The Council reviewed the agenda.

Councilman Campbell asked to strike business item F8 from the agenda.

*Councilman Campbell made a motion to strike business item F8 from the agenda moving items 9, 10, & 11 up. Councilman Williams seconded the motion. Motion carried, 5-0. Joey Campbell – aye, Todd Sands – aye, Wayne Olsen – aye, Gary Chaves – aye, Chuck Williams – aye.*

1. Review and possible approval of meeting minutes from August 6, 2025, City Council Meeting.

1. Ash Creek Special Services District Representative – Mike Chandler

Councilman Campbell reported on behalf of ACSSD providing development updates that were discussed at the last Sewer District meeting. Mike Chandler joined the meeting later and provided an update on the Confluence Treatment plant, which is 75% complete and on target to be completed by December. The district has been busy with inspections with all the new development, including Toquerville.

2. Hurricane Valley Fire District Representative – Robert Hooper

Robert Hooper introduced himself to the public, noting that he would be taking Merlin Spendlove's position, who had just retired. He mentioned the 9/11 event the Fire District will be hosting and provided some reports. The district ran 540 calls last month, 9 of which were within Toquerville.

3. Stanley Consultants – Bob Lamoreaux  
Bob provided an update on the bypass. JP is estimating to be done by the end of October.
4. Assistant City Manager – Darrin LeFevre  
Darrin shared photos providing updates on the construction of the Toquerville bypass, Firelight, Sapp Bros., Chief Toquer Reservoir, and IME Automations.
5. City Manager – Ben Billingsley  
Ben reported on the parkway opening, acknowledging the traffic confusion that followed. He also addressed City communications and outlined the Code Enforcement process. Additionally, Ben discussed the Department of Environmental Quality's transition from a tax-based entity to a fee-based entity. He provided updates on the Westfield connection road and shared highlights from the most recent Legislative Policy Committee by the Utah League of Cities and Towns.

Councilman Sands provided an update on the Southwest Mosquito Abatement. The district sets out around 35 traps weekly throughout Washington County and 5 outlying areas. Mosquito collections are down half compared to this same time last year.

Mayor Sip opened the Public Forum by reading an email from DC Young regarding the status of the Westfield Road connection to the Toquerville Bypass. Dan Catlin then addressed the Commission about the secondary access from Westfield Road to the Bypass, as well as code enforcement and Toquer Hills Phases 1–4 from March 10, 2021. Stacy Eaton followed with comments on the Westfield Road connection and the Firelight development. Scott McCall, representing Firelight, offered clarification on the Westfield Road connection.

Emily summarized the application submitted by Raymond and Kathy Bence also adding comments made by Planning Commission. Attorney Gothard went over the consistency with the General Plan.

*Councilman Campbell made a motion to approve the Zone Change application submitted by Raymond and Kathy Bence. Councilman Sands seconded the motion. Motion carried, 4-0. Roll Call Vote: Chuck Williams – abstain, Gary Chaves – aye, Todd Sands – aye, Wayne Olsen – aye, Joey Campbell – aye.*

James Elegante with Jenkins Bagley Sperry, via zoom, spoke about the Policies and Procedure Manual. The Council discussed reviewing the manual and making a list of questions, then coming back for discussion.

Emily introduced this item summarizing the modification application and providing background information. Attorney Gothard answered questions from the council. Councilman Campbell pointed out a mistake made on the site plan.

Councilman Williams seconded the motion. Motion carried, 5-0. Roll Call Vote: Joey Campbell – aye, Wayne Olsen – aye, Todd Sands – aye, Gary Chaves – aye, Chuck Williams – aye.***

4. **Discussion and possible action** on a proposed addendum to the Firelight Development Agreement allowing conditional approvals on select land use applications.

Attorney Gothard introduced the item, providing background information on the proposed addendum and outlining the process involved. She, along with Ben and Emily, responded to questions from the Council regarding approvals, timelines, and procedural steps. Mayor Sip then invited Doug Westbrook to speak on the item. Mr. Westbrook shared his thoughts on the property and expressed his opinion regarding the proposal. Jim Ence also provided comments on the item.

***Councilman Campbell made a motion to approve the addendum to the Firelight Development Agreement with the verbiage stating anything except any land use application that would require payment of a fee to somebody other than the city. Councilman Williams seconded the motion. Motion carried, 4-1. Roll Call Vote: Chuck Williams – aye, Gary Chaves – aye, Todd Sands – aye, Wayne Olsen – nay, Joey Campbell – aye.***

5. **Discussion** on recreational opportunities at Chief Toquer Reservoir.

Ben presented slides showing potential plans for Chief Toquer Reservoir going over recreational opportunities for the city, funding, and the creation of a committee. Mike Chandler commented on this item providing the sewer districts input on the project.

Ben reviewed the plan for completing Westfield Park within budget and explained two paths forward for getting the remaining construction completed. He then answered questions from the Council regarding park design, contracted work, and funds for the park.

*Councilman Olsen made a motion to pursue the possibilities on building Westfield Park. Councilman Williams seconded the motion. Motion carried, 5-0. Joey Campbell – aye, Todd Sands – aye, Wayne Olsen – aye, Gary Chaves – aye, Chuck Williams – aye.*

7. **Discussion and possible action** on a trail installation payment in lieu agreement with Sapp Bros.

*Councilman Campbell made a motion to approve the payment in lieu of the agreement with Sapp Brothers for \$191,438.00. Councilman Williams seconded the motion. Motion Carried, 4-1. Roll Call Vote: Chuck Williams – aye, Gary Chaves – aye, Todd Sands – nay, Wayne Olsen – aye, Joey Campbell – aye.*

8. **Discussion** of proposed sign regulations for the I-15 Corridor.
