Mr. Mayor,

As the Chairperson of the New Harmony Valley Special Service District (NHVSSD), I am writing to request your assistance in a matter recently brought before the NHVSSD Administrative Control Board (NHVSSD-ACB). Chief Banks was recently given an invoice (dated 6/30/25) for \$ 1,990.44 by your clerk. Ms. Hecker, Clerk New Harmony Township, after handing him the invoice, stated, "that the invoice is for one-half the town station utilities for the last 2 years, even though I had not billed the district in the last four years." In reviewing the attached invoice, you can see that some of that is also handwritten on the actual invoice.

For a better understanding, please be advised that none of the current NHVSSD Board members were present on the Board in 2021 and were unaware of the policy/procedure that is now being implemented. Therefore, we directed our Office Manager to research past payments made to the town and the frequency. She discovered payments were made on a periodic basis to the town for what was noted as "utilities/ maintenance." The dates are as follows:

It is clearly apparent that at some point in time there was an agreement or policy put into practice between the Town of New Harmony and the Fire District, and this board does not have access to that agreement. The Fire District Board supports paying for what was originally agreed upon and requests assistance with the following:

A. The district respectfully requests the town forward a copy of the financial agreement previously made between the town and the district. To prevent similar situations from occurring in the future, the NHVSSD-ACB will review the document and upon agreement adopt it into the NHVSSD's Procurement Policy Manual. If no such formal agreement exists or can't be retrieved, we suggest that the two entities come together to formalize an agreement.

- B. We request the town invoice the district on a consistent monthly or quarterly basis with copies of the utility invoices attached so that our records have appropriate financial recordings. In addition, this will allow us to track and add this expense to our budget next year and will provide the town with more consistent revenue.
- C. The district closed our 2021, 2022, 2023, 2024 fiscal budgets. Retroactive billing does not appear to be fiscally responsible for either the district or the town. We request that the current bill be modified to show billing from January 1, 2025, to present with attached supporting invoices and subsequent billing to follow. The previous years we received no request for payment and subsequent retroactive invoicing is questionable.

If you would like to discuss this further, I would welcome a conversation anytime our schedules allow. I would also be willing to attend your town council meeting at your invitation. Your assistance in this matter is sincerely appreciated.

RESOLUTION NO. (1) 2025

A RESOLUTION OF THE NEW HARMONY TOWN COUNCIL AND THE NEW HARMONY SPECIAL SERVICE DISTRICT ACB REGARDING SHARED UTILITY COSTS FOR THE FIRE STATION LOCATED AT 133 EAST CENTER STREET.

WHEREAS, the New Harmony Town Council ("Town") and the New Harmony Special Service District ACB ("District") mutually utilize the fire station located at 133 East Center Street, New Harmony, Utah ("Fire Station"); and

WHEREAS, the Town and the District recognize the need for a fair and equitable method of allocating utility costs associated with the operation of the Fire Station: and

WHEREAS, the Town and the District desire to formalize an agreement regarding the sharing of utility costs.

NOW THEREFORE, BE IT RESOLVED BY THE NEW HARMONY TOWN COUNCIL AND THE NEW HARMONY SPECIAL DISTRICT ACB AS FOLLOWS:

Cost Sharing Agreement

The Town and the District agree to share the utility costs associated with the Fire Station located at 133 East Center Street, New Harmony, Utah equally.

Each entity shall be responsible for fifty percent (50%) of all utility expenses, including but not limited to electricity, natural gas, water, sewer and garbage services.

2. Payment Terms

Utility costs shall be calculated and invoiced on a quarterly basis. Each entity shall remit payment for its fifty percent (50%) share within thirty (30) days of receipt of the quarterly invoice.

3. Administration

The Town Clerk, or designee, shall be responsible for collecting and maintaining utility billing statements, preparing quarterly invoices, and ensuring timely reconciliation of payments. The District shall designate a representative to coordinate with the Town regarding payment processing record keeping.

4. Duration and Review

This resolution shall remain in effect until amended or rescinded by mutual agreement of both parties.

The Town and the District shall review the cost-sharing arrangement annually to ensure continued fairness and effectiveness.
