1. Call to Order

II. 2025 PRIMARY MUNICIPAL ELECTION CANVASS

1. Certification of Election Report by the Municipal Legislative Body Acting as the Board of Canvassers (Trina Cooke, City Recorder)

City Recorder and Election Official for Heber City, Trina Cooke, presented the official Primary Election results as provided by the Wasatch County Clerk and Election Official Joey Granger, as included in the meeting documents. She explained CURE letters were sent to voters when a ballot failed the signature verification. The voter needed to provide proof of identity for their ballot to be counted.

Under-votes and over-votes were discussed. Mayoral candidates Heidi Franco and D. Scott Phillips would proceed to the General Election. Council Member candidates Yvonne Barney, Morgan Murdock, Nick Lopez, and Corey Noyes would also appear on the General Election ballot.

Motion: Council Member Phillips moved to certify the election results as presented in the Canvass Report.
