These individuals appeared before the City Council and expressed their concerns regarding the motocross track. These concerns mainly centered around track location. They expressed how they feel this track could bring Fairview a lot of revenue, how great it would be for the kids of Sanpete County, how this location, though not perfect, may be as good as any, etc. They also mentioned this track location could help to raise funds for a different, larger location. Mayor Welch tabled the item to a further meeting. He stated evaluation of comments and rules will take place and discussion will continue at the next City Council Meeting.
