# Dear Superintendent,

The Lumen Scholar Institute School Board approved LEA-Specific educator license(s) to *one* (1) individual in a public meeting held on *September 18, 2025*. # Director's Monthly Report - September 18, 2025

# 1. Executive Summary

**USBE Prenotification Letter for CSI Exit** - The school received a prenotification letter that we may be exiting Comprehensive Support and Improvement (CSI) - Low Graduation Rate. Once all data is finalized, the state will update the school's accountability report in December/January.

- Class of 2025 Graduation Rate 89.66%
- The current number of 12th graders missing one or more credits and at risk of not graduating is 11. All students are scheduled to work with the credit recovery team this year.


**USBE Special Education Monitoring Visit** - The state will conduct a Special Education (SPED) monitoring visit on October 23, 2025. Mandy Kartchner, Lumen's new contracted SPED Director, will lead this visit. During the visit, the state will inspect student records, interview parents and principals, and observe our SPED teachers during online classes.

# 2. Enrollment & Advertising

**Student Enrollment** - Current enrollment stands at 456 students. At this time, we do not anticipate opening additional seats for the remainder of the school year. This decision is guided by enrollment data, which consistently shows that students who enroll mid-year are significantly less likely to continue enrollment into the following school year. Historically, mid-year retention rates fall well below those of students who begin with us at the start of the year, making additional enrollments an inefficient investment of school resources.

In addition, mid-year enrollments present challenges at the classroom level. Teachers must redirect time and attention to train new students on technology platforms, learning routines, and classroom expectations. While necessary, this onboarding process disrupts the flow of instruction and reduces time spent teaching and supporting existing students.

By limiting enrollment to the start of the academic year, we can better support teacher effectiveness, maintain instructional continuity, and focus our recruitment strategies on families most likely to remain with us long-term.



**Website Refresh -** As part of our efforts to attract and retain students, we are preparing to update our school website with a refreshed design. Best practices in digital communication

recommend refreshing a website every few years to ensure it remains modern, user-friendly, and aligned with current branding. Our website was updated three years ago, so a refresh is needed.

**Advertising -** Over the past several years, the school has partnered with contracted firms to strengthen our digital presence through Search Engine Optimization (SEO) and expanded advertising on social media platforms. We are now in the process of reviewing these agreements to evaluate their effectiveness and alignment with our enrollment goals. This review will guide our next strategic steps in marketing Lumen to prospective students and families, ensuring that our resources are invested in approaches that deliver measurable results and support long-term growth.

# 3. Academics

**Reading Intervention Program, 6th-12th Grade** - This year, a part-time reading interventionist was assigned to support secondary students. In early September, the intervention team administered a reading screener to all secondary students. Those who scored below the expected reading level are now undergoing additional evaluations, and students identified with ongoing needs will receive targeted reading intervention services.

# 4. Facility

We are working on space planning the current building and will provide updates as we make progress with those plans.

# **Reporting of Suspected Child Abuse and Neglect**

# **Policy**

- 1. The Board of Trustees is committed to the safety of its students and will follow state mandates regarding reporting and handling of child abuse and neglect as outlined in Utah Code § 80-2-602, Utah Code § 53E-6-701, and Administrative Code Rule R277-401.
- 2. Utah law requires the reporting by any school employee or volunteer who has reason to believe a child has been abused or neglected. Such reports shall be made to the Division of Child and Family Services or to the nearest peace officer or law enforcement agency.
- 3. Utah law further requires that whenever any school employee or volunteer has reasonable cause to believe that a student may have been physically or sexually abused by a school employee or volunteer, that person shall immediately report that belief and all other relevant information to school administration or the Utah State Board of Education. If a school administrator receives such a report, or if a school administrator otherwise has his/her own reasonable cause to believe that a student may have been physically or sexually abused by a school employee or volunteer, the school administrator shall immediately report that information to the Utah State Board of Education.
- 4. To implement this law, the Board authorizes school administration to develop administrative regulations for school employees and volunteers to comply with and carry out the requirements of the law.

Utah law further requires that whenever any school employee or volunteer has reasonable cause to believe that a student may have been physically or sexually abused by a school employee or volunteer, that person shall immediately report that belief and all other relevant information to school administration or the Utah State Board of Education. If a school administrator receives such a report, or if a school administrator otherwise has his/her own reasonable cause to believe that a student may have been physically or sexually abused by a school employee or volunteer, the school administrator shall immediately report that information to the Utah State Board of Education.
- 4. To implement this law, the Board authorizes school administration to develop administrative regulations for school employees and volunteers to comply with and carry out the requirements of the law.

It is Lumen's goal to provide students with rich and ample opportunities to use technology for important purposes in school just as individuals in workplaces and other real-life settings. Lumen technology will enable educators and students to communicate, learn, share, collaborate and create, to think and solve problems, to manage their work, and to take ownership of their education.

Internet safety is a priority at Lumen. As a result, Lumen will use reasonable efforts to (1) prevent user access over its computer network to inappropriate material via the Internet, e-mail, or other forms of direct electronic communications; (2) prevent unauthorized access and other unlawful online activity; (3) prevent unauthorized online disclosure, use, or dissemination of personal identification information of minors; and (4) comply with the Children's Internet Protection Act.

The Board of Trustees delegates responsibility to the Chief Administrative Officer to create strong electronic educational systems that support innovative teaching and learning; to provide appropriate staff development opportunities that promote appropriate, responsible, and safe technology, network, and Internet use; and to develop procedures to support this policy.

Expectations for student and staff behavior online are no different than face-to-face interactions.
