## RESOLUTION No. 2025-31

### A RESOLUTION EXTENDING CERTAIN SHORT-TERM PROJECTS COMPLETION DATES

**WHEREAS**, the Central Wasatch Commission (the “CWC”) is an interlocal entity formed in 2017 whose principal purpose is to better assure the wise stewardship of the Wasatch mountain range (the “*Central Wasatch*”) in Salt Lake, Summit and Wasatch counties—including its watershed, recreational areas and natural beauty—so that future generations can continue to benefit from that wonderful and integral part of Utah’s natural environment; and

**WHEREAS**, annually, the CWC’s Short-Term Projects Committee (the “*Committee*”) analyzes requests from third parties for funding of so-called “short-term projects” which are believed will provide prompt, noticeable improvement of adverse issues affecting the Central Wasatch; and

**WHEREAS**, the Board of Commissioners (the “*Board*”) of the CWC heretofore has approved by resolution various short-term projects recommended by the Committee to the Board for implementation during the CWC’s 2024-25 fiscal year; and

**WHEREAS**, completion of the three projects specified on the attached exhibit has been delayed; and

**WHEREAS**, on 25 September 2025 the Board met in regular session to consider, among other things, extending the completion dates for such three projects as shown on the attached exhibit; and

**WHEREAS**, after careful consideration, the Board has determined that it is in the best interests of the health, safety and welfare of the CWC and its constituents to so act;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Central Wasatch Commission interlocal entity that the completion dates for such three projects is hereby extended as shown on the attached exhibit.

This Resolution, assigned no. 2025-31, shall take effect as provided herein.
