BOARD REPORTS

Commissioner Taylor reported on PILT. He will be attending the upcoming PILT fly in. He also attended a commission briefing tour in Beaver. He reported that Antimony Town experienced flooding from recent rainfall, and the inmates will be assisting with sandbagging preparation.

Commissioner Pollock reported on the Hospital Foundation Dinner. There was discussion on the lack of timber sales. He met with congresswoman Maloy to discuss SRS. He attended a grazing meeting in Junction. Commissioner Pollock noted he continues to receive questions about Promise Rock and clarified that the County is not closing Proctor Canyon Road.

PUBLIC WORK BUSINESS

Dave Dodds, Public Works Director, reported that the 6th Grade class participated in a cleanup project at the John's Valley Landfill as a fundraiser.
