Senate Bill 50 (2025)



SB 50 Overview

- Rural board members volunteering in districts
- Eliminates compensation limit for a member of a board of trustees
- Requires entity to hold public hearing on proposed increase
- Current limit is \$5,000 annually
- In 2007, increased from \$3,500 to \$5,000
