

6. Discussion/Action Items:

- a. Consideration of American Legion request to use storage space at the Mt. Pleasant*

This item has been cancelled as the party is no longer interested in the space.

- b. Consideration and possible approval of moving the Mt. Pleasant Rodeo Arena to the Cleone Peterson Eccles Equestrian Center (Contoy Arena)*

Jack Widdison reported that the new arena has the capacity for approximately 1,000 permanent seats, with an additional 600–700 portable seats. There will also be room to expand seating in the future. Discussion was held on the possibility of relocating some seating from the current arena.

A high school rodeo is scheduled at the new arena on October 16, 2025, which will serve as a trial run. Jack encouraged all Council Members to tour the facility.

Concerns were expressed regarding holding a final rodeo at the current arena, as Councilman Beesley noted it has become a safety hazard. Cache Valley Electric will be donating lighting for the new arena. Discussion also included how to move the existing bleachers.

It was suggested that a special meeting be held at the site with the Council and Mayor. The Council will plan to meet at the next Work Session at 5:30 p.m. to tour the area, with the matter to be brought back for a vote at the next City Council meeting.

7. Public Participation

Members of the public may address the City Council on matters not listed on the agenda. Those interested should sign up on the form just inside the council room door prior to the start of the meeting. Participation is limited to three minutes. Each participant will be allowed to address the Council and may submit documents outlining their issue. The Council cannot take legal action on public comment at this time. At the conclusion of each comment, the Council will have time to respond to criticism made by those who have addressed them, may ask staff to review a matter or may ask that a matter be placed on a future agenda. All City Council meetings are recorded.

Shane Ward provided an update on the hydro. He explained that the unit will need to be shipped back for a cold alignment at an estimated cost of \$5,000, for which a requisition will be prepared. He noted the hydro should be back up and running within the next two weeks.


8. Council Reports
