Request to decommission one (damaged) generator purchased in 2013 with CIB loan funding to then add a solar PPA to its electrical generation mix.

On July 11, 2013, the Permanent Community Impact Fund Board authorized a \$600,000 loan for 30 years @ 1.5% to Ticaboo Utility Improvement District for the acquisition and installation of power system components, including new power generation equipment, a closed automatic transmission switch, an 80 kvAR reactor, and monitoring equipment.
