- **Approve LEA Licenses**

- Amended Bullying and Hazing Policy  
Jeff Hall addressed the changes to the bullying and hazing policy. The definitions in the policy will be helpful for staff and teachers when addressing issues that may arise. The Bullying and Hazing Policy was updated to align with SB 223 and USBE Rule R277-613, incorporating new definitions of staff and student bullying, clarifying civil rights violations, prohibiting the creation or sharing of explicit images, and adding safe digital citizenship to required training topics.

- New Hotline Complaint Policy  
The new Hotline Complaint Policy was adopted to comply with R277-123, outlining how the school will respond to hotline complaints, directing complainants to use existing grievance policies when appropriate, and maintaining a link on the school's website to the USBE public education hotline. Sandy Shepard suggested a slight change to the new hotline policy adding in that complaints will be responded to by the director or administrative designee.
