ADMINISTRATIVE MATTERS

Call to Order:

The meeting was called to order at 6:57 p.m. by Trustee Derck, who recited the following:

FINANCIAL MATTERS

Public Hearing on the District’s Proposed Property Tax Increase:

Trustee Schultz made a motion to open the public hearing on the District’s proposed property tax increase at 6:58 p.m. Trustee Robinson seconded the motion. The motion passed unanimously.

It was noted that publication of Notice stating that the Board would consider a proposed

property tax increase and the date, time and place of the public hearing was made in a newspaper having general circulation within the District. No written objections were received prior to the public hearing.

No public comments were received, and Trustee Schultz made a motion to close the public hearing at 6:59 p.m. Trustee Robinson seconded the motion. The motion passed unanimously.

Resolution Levying the Ad Valorem Property Tax of the District at a Rate Exceeding the Certified Tax Rate for Fiscal Year 2025-2026:

Trustee Derck reviewed the resolution with the Board and facilitated public comment. Trustee Schultz made a motion to adopt the Resolution Levying the Ad Valorem Property Tax of the District at a rate exceeding the Certified Tax Rate for Fiscal Year 2025-2026. Trustee Robinson seconded the motion. The motion passed unanimously.
