ORDINANCE NO. 25-46

AN ORDINANCE AMENDING THE 2009 WEST JORDAN CITY CODE;
AMENDING SUBSECTION 14-5-5(C)(2)
(PROVIDING FOR A TRAFFIC CALMING MANUAL FOR NEW DEVELOPMENT)

WHEREAS, the City of West Jordan (“**City**”) adopted West Jordan City Code (“**City Code**”) in 2009; and the City Council of the City (“**Council**” or “**City Council**”) desires to amend City Code Subsection 14-5-5(C)(2), to allow for a “Traffic Calming Manual for New Development” (“**proposed City Code amendments**”); and

WHEREAS, the Planning Commission of the City (“**Planning Commission**”) held a public hearing and provided a recommendation on September 2, 2025, regarding the proposed City Code amendments; and determined the following, pursuant to City Code Section 13-7D-6B:

1. The proposed City Code amendments conform to the General Plan and are consistent with the adopted goals, objectives and policies described therein;
2. The proposed City Code amendments are appropriate given the context of the request and there is sufficient justification for a modification to the land use titles;
3. The proposed City Code amendments will not create a conflict with any other section or part of the land use titles or the General Plan; and
4. The proposed City Code amendments do not relieve a particular hardship, nor do they confer any special privileges to a single property owner or cause, and they are only necessary to make a modification to the land use titles in light of corrections or changes in public policy; and

WHEREAS, the City Council held a public hearing on September 23, 2025, regarding the proposed City Code amendments, and finds it to be in the best interest of the public health, safety, and welfare of the residents of the City to adopt the proposed City Code amendments.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST JORDAN, UTAH AS FOLLOWS:

Section 1. Amendment of City Code Provisions. With regards to the City Code, Subsection 14-5-5(C)(2) is amended, as shown in Attachments A (legislative version) and B (clean version) to this Ordinance.

Section 2. Severability. If any provision of this Ordinance is declared to be invalid by a court of competent jurisdiction, the remainder shall not be affected thereby.

Section 3. Effective Date. This Ordinance shall become effective immediately upon posting or publication as provided by law and upon (i) the Mayor signing the Ordinance, (ii) the City Council duly overriding the veto of the Mayor as provided by law, or (iii) the Mayor failing to sign or veto the Ordinance within fifteen (15) days after the City Council presents the Ordinance to the Mayor.

Legislative Version

14-5-5: STREETS:

....

C. General Design Principles:

1. Public and private streets are designed to minimize cut-through traffic in residential areas.
2. ~~Local street designs incorporate traffic calming measures to reduce vehicle speeds and promote pedestrian safety. The city requires traffic calming measures for new local streets to target a mean vehicle operating speed of 25 miles per hour (mph). To achieve this objective, the maximum length of roadway section between speed control points shall be 500 feet. For a definition of speed control points and design instructions, see the City of West Jordan: Traffic Calming Manual for New Developments. The type and number of required speed control points is subject to review and approval by the city's traffic engineer.~~
3. Streets are designed to provide safe and convenient access between neighborhoods and to comply with the level of service standards identified in section 13-7A-3. Local streets should be extended to provide access between adjoining neighborhoods at appropriate intervals.
