Minutes

A meeting of the Naples City Council was held September 11, 2025, 7:30 p.m., at the Naples City Office, 1420 East 2850 South, Naples, Uintah County, Utah.

DATE, TIME & PLACE OF MEETING

Council members attending were Dean Baker, Robert Hall, Dan Olsen, Ross Morton, and Kenneth Reynolds. Andrew Bentley was absent.

COUNCIL MEMBERS ATTENDING

OTHERS ATTENDING

Mayor Baker welcomed everyone and began the meeting with the pledge of allegiance. Robert Hall offered the invocation. Mayor Baker asked if everyone would participate in a moment of silence in honor of 9/11 and recent events.

OPENING CEREMONY

Mayor Baker asked for approval of the agenda and asked if Micheal could give an update under other matters regarding the park trail project. Kenneth Reynolds **moved** to approve the agenda with the park update under other matters. Ross Morton **seconded** the motion. The motion passed with all voting aye.

APPROVAL OF THE AGENDA

The minutes of the city council meeting of August 28, 2025 were presented for approval. Ross Morton **moved** to approve the minutes. Robert Hall **seconded** the motion. The motion passed with all in attendance voting aye.

MINUTES APPROVED

Mayor Baker asked if anyone had anything they would like to follow up with from the previous meeting. Nothing was brought forward.

FOLLOW UP MATTERS

Nikki Kay presented the bills in the amount of \$108,544.69. Dan Olsen **moved** to approve the bills as presented. Kenneth Reynolds seconded the motion. The motion passed with the following roll call vote:

A business license application was received from Keith and Al Jean, Inc. located at 1401 E 1100 S. Nikki explained the owners will be manufacturing cabinets that they will sell from their store located in Vernal City. Kenneth Reynolds **moved** to approve the business license. Dan Olsen **seconded** the motion. The motion passed with all in attendance voting aye.

APPROVAL OF BUSINESS LICENSES

A business license application was received for Country Villa, located at 1783 E Split Mtn Drive. Mayor Baker said the license application looked to be for a short term rental. He stated it looked like all the needed information was provided. Robert Hall **moved** to approve the license. Kenneth Reynolds **seconded** the motion. The motion passed with all voting aye.

Mayor Baker stated staff might need to check on another short term rental that is located in Park View subdivision.

Brittany Schlosser came before the Council to give an update on activities and budget for the Naples Elementary PTA. Ms. Schlosser stated they have the Fall Festival coming up on Sept. 19th and said, because of local business donations, they are able to have the cost much lower. She said this is the one fund raiser the PTA does during the year. Ms. Schlosser shared the approved budget for the PTA for the upcoming year. She thanked Councilman Hall for participating as a PTA member last year and handed out membership information to the Council. Each member of the Council chose to participate and become a member this year. Ms. Schlosser thanked the Council for being a partner with the PTA last year and asked if they could maintain the pledge from last year. Councilman Hall stated the City does have a budgeted amount they have approved. Micheal stated the amount budgeted for this was \$700. Mayor Baker suggested they increase the amount to \$1,000. After some discussion, Dan Olsen **moved** to approve \$1,000 for the sponsorship of the Naples PTA. Ross Morton **seconded** the motion. The motion passed with the following roll call vote:

Mayor Baker asked Micheal to give an update on the park trail project. Micheal shared some pictures he had taken at the park showing the dirt trail on the east end with the retaining walls and the cleared area on the 2000 East side that will be a dirt parking lot. He stated the contractors will be moving to the highway side next week and will be working on the parking lot and the trail on the back side of the softball fields. Micheal stated they should have two more weeks of leveling and then they will start to pave. Micheal said the engineer is working on change orders for the Nash driveway and the Stevens' fence. Councilman Hall commented on how good it is to see how well the park is utilized.
