2. Approve Minutes for 9/4/25 Council Meeting: Motion to approve the minutes made by Gary, 2nd by Kam, Cherrie yes.

3. Adopt the Agenda: Motion to adopt the agenda – will have elementary present then the high school athletics- made by Gary, 2nd by Kam, Cherrie yes.

4. Other Business:

A. Shuttle Building Enhancement Design Project: Have received two bids so far. One contractor concerned about suggested quantity needed, he feels it will take more supplies. Need to compare bid documents to what was requested by engineer. May need a meeting next week to review. Keep on agenda for next meeting to approve bid.

B. Town Park Remodel Project: Will dry scape entire area on Main Street. Public meeting for input will be held Tuesday-September 23rd 5:00-6:00PM at the town park. Will provide food. Need to get the notices out.

C. BVES 6th Grade Washington DC Trip Donation: - Students presented their annual trip plan. All funds raised will go directly to students. Total cost is \$900/per student. Will charter a to Las Vegas to fly out. Have 16 students going. Have held previous fundraisers and raised \$15,000 so far. Currently selling fan blankets. Motion to approve \$2,000.00 donation made by Gary, 2nd by Kam, Cherrie yes.

D. Fire Department Inter-Local Agreement: Fire Chief Harris present, to discuss the Restated Interlocal Cooperation Agreement. This includes Resolution 2025-3. In 2024 Bryce City and Tropic joined departments, Henrievile wants to join and needs to have an agreement. A restated agreement has been presented by Henrievile. Henrievile has new firefighter members that are very active. Henrievile will function separately for budgeted purposes. Having a function department helps with fire ratings and insurances. Will have fire classes in January 2026.

Motion to approve the restated interlocal agreement and Resolution 2025-3 made by Gary, 2nd by Mike, Kam yes, Cherrie yes.

Mike entered meeting during discussion on Fitness Equipment.

E. Bryce Valley High School Fitness Equipment: Ty Post & Principal Ott present with BVHS athletic students to present their purpose. Wanting to purchase equipment for the new facility at the high school. Want to focus on having a nice weight room and center for the students. They do have a weight class for PE this year. Current equipment is old and not safe. The weight room will be open to the public. They are trying to raise around \$20,000. Will use the same company the city uses- Upper Limit to maintain the equipment. Building should be complete the end of October. Very appreciative for Bryce City in always being able to help. This is very beneficial to the students of Bryce Valley. Motion to approve \$15,000.00 made by Kam, 2nd by Gary, Cherrie yes, Mike yes.

F. Cemetery Plot Section E-5, #15-Martel: Cherrie received a request for a plot purchase. Motion to approve made by Mike, 2nd by Kam, Gary yes, Cherrie yes.

Cherrie had question on purchasing one plot to bury two individuals- one cremation and one casket burial on the same plot. Can two people be buried on same plot. Need to follow ordinance. It's not easy to plot multiple burials on one plot. Not sure how deep it can be dug there before hitting rocks. Follow up on ordinance. For now, only allow one burial per plot.

Main Street – Landscaping near Tesla chargers complete. Main Street needs some trimming on the sidewalks. Jean recommends just trimming up and plan the big clean up next Spring.
