<b>Notes</b>	<p><b>a. A.R.</b> The Committee discussed A.R.'s complaint. A.R. was present and spoke with the committee. A.R. told the committee that his complaint centers on several instances where they believe their rights as a victim were violated, leading to compound traumas elicited by interacting with criminal justice spaces. A.R. spoke about the Sentencing Hearing and how being in close proximity to the defendant was traumatic causing feelings of intimidation and powerlessness. A.R. also spoke of the ongoing fraud investigations related to the defendant. A.R. spoke of how they feel this violated their right to a speedy disposition of the criminal justice process. The committee discussed the definition of a victim in the victims' rights statutes and whether or not A.R. qualifies as a victim. Mr. Ryder expresses a desired outcome of the complaint to be accountability and systemic improvement of the criminal justice system.</p> <p><b>Motion:</b> No motion was made due to a lack of quorum.</p> <p><b>Action Item:</b> Katie Fox will send the recording of this meeting to the committee members who were not present for review prior to the next meeting.</p>
