Amir Caus, *AICP Senior Planner*, presented a brief introduction for the mixed-use redevelopment project at Junction Commons (6:08 P.M.)

Adam Greenebaum, *Senior Vice President, Asset Management for Singerman Real Estate*, addressed the commissioners and supported the Master Planned Development introduced by Senior Planner Caus. (6:13 P.M.)

Craig Elliott, *Principal with the Elliott Workgroup*, provided a short history of the project and highlighted specific items within the project for discussion. (6:15 P.M.)

Commissioner Nagie asked for more detail regarding affordable housing. Justin Keys, *Hoggan Lee Hutchinson*, addressed his concerns. Mr. Elliott reviewed the housing numbers phase by phase. (6:31 P.M.)

Commissioner Young asked follow-up questions on affordable housing, community engagement, and green space. The applicants responded to his concerns. (6:37 P.M.)

Commissioner Peteroy thanked the applicants for their presentation and asked questions about the mix of affordable housing and traffic. (6:47 P.M.)

Commissioner Jeffrey requested elaboration on the height and roof of the parking structure as well as traffic. Applicants responded. (6:51 P.M.)
