**Municipal
Partnership Grant
Program Status
Update**

Mr. Courtney Brown, Conservation Division Manager, provided a status update on the Municipal Partnership Grant Program, which is funded by Salt Lake County through ARPA and administered by JVVCD. He indicated that the three-year program (2023–2025) offers \$ 3 per square foot. ft. for turf conversion projects, primarily for cities. He mentioned that in January 2023, the Board approved reopening the budget to add \$2 million in funding, with the third payment received from Salt Lake County in November 2024. Mr. Brown remarked that to date, \$1.7 million has been allocated, supporting the replacement of 445,000 sq. ft. of lawn and \$1.3 million in rebates to cities. He explained that some funds were directed through Taylorsville, Sandy, Millcreek, and Herriman to property owners in those cities to participate in Utah Water Ways demonstration projects that promote awareness through media. The remaining funds covered JVVCD administration and a marketing/outreach consultant.

Mr. Brown provided a status report of the program, highlighting six newly completed projects not previously shown to the Board, including sites in Murray, Riverton, Sandy, South Jordan, Taylorsville, and West Jordan. He mentioned notable projects included a substation near Fashion Place Mall, Bicentennial Park frontage, and bullpen areas in South Jordan. Mr. Brown said the Taylorsville project, using hybrid Bermuda grass (a program first), received strong media coverage. In West Jordan, turf was removed from parking islands at Veterans Memorial Park.

Mr. Brown reported that there are four remaining projects, with three expected this fall and one in 2026. Those projects are Herriman Main Street, Sandy Public Utilities park strip, a pollinator garden for the Utah Department of Agriculture, and West Valley City Hall landscaping.

The Board discussed a question about the Utah Water Ways homeowners, confirming that Alan Packard attended a press event at

the Taylorsville site, where "how-to" videos were filmed for the public. The conversation also covered the pros (low water/fertilizer use) and cons (winter dormancy) of hybrid Bermuda grass, along with a note on classifying invasive grasses.


Mr. Erik Wermel, Conservation Programs Supervisor, highlighted several 2025 waterwise projects, including a desert-style landscape in Draper (saving 25,657 gallons), a pollinator garden in Herriman (saving 42,317 gallons), and a 3,500 sq. ft. foodscape in Midvale (saving 98,000 gallons). He also reviewed the projects featuring pathway conversions in Riverton (saving 42,317 gallons) and South Jordan (saving 38,771 gallons), a DIY raised bed in Taylorsville (saving 70,000 gallons), a private fire pit space in West Jordan (saving 172,498 gallons), and front yard water-saving landscape changes in West Valley City (saving 59,712 gallons). Mr. Wermel emphasized that foodscapes foster social connections and noted that over 50% of projects were DIY.

Reporting Items



A question was asked about the field and garden improvements, and Mr. Young clarified that timing depends on UDOT's 1300 West widening project, with related easement items on Wednesday's agenda.
