

RESOLUTION NO. 25-02

A RESOLUTION OF THE TABBY VALLEY PARKS AND RECREATION SPECIAL SERVICE DISTRICT, CANCELLING THE NOVEMBER 4, 2025, GENERAL ELECTION AND DECLARING EACH UNOPPOSED CANDIDATE ELECTED TO THE BOARD.

WHEREAS, the Tabby Valley Parks and Recreation Special Service District provides that the Board Elections shall be held in accordance with the laws of the State of Utah; and,

WHEREAS, Utah Code Annotated § 20A-1-202 establishes the first Tuesday after the first Monday in November of each odd-numbered year for the purposes of conducting a municipal general election; and

WHEREAS, no proposition is to appear on the ballot in the election; and

WHEREAS, the filing deadlines for placement on the ballot and declaration of write-in candidacy have passed;

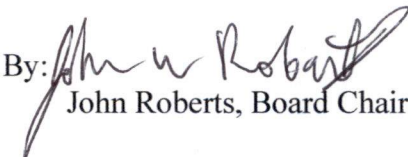
WHEREAS, each board officer candidate is unopposed; and

WHEREAS, Utah Code Annotated § 20A-1-206 specifically provides for a process whereby the Board may cancel a special service district general election when the series of events identified above has occurred and upon compliance with applicable law.

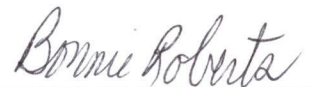
