

THE BASIS OF BEARING FOR THIS SURVEY IS N 01°07'14" E BETWEEN THE SOUTHWEST CORNER OF SECTION 6 AND THE WEST QUARTER CORNER OF SECTION 6. THE BOUNDARY IS ESTABLISHED BY THE FOUND SECTION MOUNTENTS AND SURVEY REBARS AND CAPS PLACE BY A BUSH AND QUDGELL SURVEY DOCUMENT NO. R5002356_97. THE AFORE MENTIONED SURVEY WAS ROTATED COUNTER CLOCKWISE TO MATCH THIS SURVEY'S BASIS OF BEARING.
