#### **1. Call to Order**

Board Chair Eric Barney, presiding, called the meeting to order at 5:30 PM.

**B. Approval of Resolution R2025-04, Approving the Conveyance of Real Property to Magna City**

David Brickey noted that the two properties listed in this Resolution were intended for conveyance to the City of Magna, however they were conveyed by the county to the Community Reinvestment Agency. He asked the council to approve this resolutions, transferring the two parcels, Parcels 2 and 3, allowing them to be joined as a single park.

Mayor Eric Barney clarified that these parcels are outside the boundaries of the CRA, which was confirmed by Mr. Brickey.

**Board Member Hull moved to approve Resolution R2025-04, Approving the Conveyance of Real Property to Magna City. Board Member Sudbury seconded the motion; vote was 5-0, unanimous in favor.**

**C. Discussion and Potential Approval of Proposal for Financial/Economic Development Advisor for the Magna Community Reinvestment Agency**

Dan Torres reviewed his previously presented proposal regarding attaining a municipal advisement firm for the CRA to assist in studies and projects potentially coming up in the CRA. This current proposal mirrors what he has recommended to the City of Kearns and their CRA as they look as bonding and finance capacity. There are some opportunities for collaboration with Kearns as a “sister city” as many projects and issues will be similar, and there will be advantages to having common staff and consultants when advisement is needed. There are two proposals included for approval tonight, one for Zions Bank, which is more interested in the larger bonding for millions of dollars. There is no retainer fee for that service, they would scope and cost out any studies related to bonding through that process. His recommendation is to have them on deck to be available for those services. The Clearwater Financial Proposal is for a group out of Idaho with a retainer of \$12,000 a year, which includes “unlimited,” up to 40 hour projects. Many questions in the future will be covered under that fee and if a project/situation is identified as requiring a larger scope and project, that would allow the CRA to engage with them and consider that project.

Council Member Hull asked about the cost for Zions Bank.

Mr. Torres noted that they are free for retaining, they would charge per project and study as they became available. If a project is under 40 hours’ worth of work, they would use Clearwater for those services as they are already included in their services. He suggests having both groups on board to help with the projects they are best suited for.

**Board Member Prokopis moved to approve the proposal for a financial/economic development advisor for the Magna Community Reinvestment Agency. Board Member Sudbury seconded the motion. Vote was 4-1, majority in favor, with Board Member**

**Pierce voting “NO.” Motion carries with majority vote.**
