Tiffanie N. Robinson, Senior Planner, presented the Canyons Development Agreement Amendment to modify Section 3.15 regarding Automobile Access. Project #23-064. (4:30 p.m.)

Commissioner Matthew Nagie asked to clarify the process. Planner Robinson responded. (4:32 p.m.)

Dave Smith and Spencer White, TCFC representative, updated the Commissioners on the Canyons Development Agreement and discussed clarifications and changes to the language concerning life safety issues for Red Pine Village. Mike Owens, Fire Marshal, Park City Fire Department, supported the presentation. (4:33 p.m.)

Commissioner Makena Hawley asked if the other commissioners had any questions. (4:39 p.m.)

Commissioner Matthew Nagie inquired about fire safety information. Fire Marshal Mike Owens responded. (4:39 p.m.)

Commissioner Tim Jeffrey, we are talking about a winding road with hairpin turns. Do you feel comfortable getting people out of there? Fire Marshal Owens responded. (4:43 p.m.)

Commissioner Heather Peteroy asked, Can you tell us about how mountain towns have changed in the last 10 or 20 years? Additionally, could you discuss the evacuation thresholds or density limits? Fire Marshal Owens and Spencer White of TCFC responded. (4:43 p.m.)

Commissioner Eric Sagerman requested clarification regarding the emergency exit plan. He noted an inconsistency in stating that the gondola would serve as the primary emergency exit. He asked how many residents and vehicles would be present at full capacity in order to develop a comprehensive exit plan. Spencer White, a representative from TCFC, along with Fire Marshal Owens, responded. (4:48 p.m.)

Commissioner Heather Peteroy stated, thinking through evacuations and forest fires, obviously, this is going to drain down to Highway 224. Is Highway 224 going to become an issue? Fire Marshal Owens and Spencer White, a representative of TCFC, responded. (4:56 p.m.)

Commissioner Makena Hawley asked about the use of shuttle buses for safety and emergency situations. Fire Marshal Owens and Spencer White from the TCFC responded. (5:04 p.m.)

Commissioner Matthew Nagie asked about automobile access to the development. What criteria are there for Commissioners to look at? Planner Robinson, Community Development Director Peter Barnes, and Spencer White, a representative of TCFC, responded. (5:12 p.m.)

Commissioner Heather Peteroy wants more detailed information on capacity, density, and the number of cars that could be on the mountain, as well as how these factors influence evacuation. Spencer White, a representative from TCFC, responded. (5:12 p.m.)

Commissioner Eric Sagerman, would you contemplate a different policy for winter and summer? Commissioner Nagie and Spencer White, a representative from TCFC, responded. (5:15 p.m.)

How would the water redesign work? Planner Robinson and Public Works Director Angell responded. (6:23 p.m.)
