**A RESOLUTION OF NORTH FORK SPECIAL SERVICE DISTRICT CHANGING THE RATE
OF GARBAGE SERVICE CHARGES AND THE EFFECTIVE DATES THEREOF
RESOLUTION 2025-05.**

WHEREAS, the Utah County Board of County Commissioners (“**Board of Commissioners**”) created the North Fork Special Service District (“District”) on October 7, 1977;

WHEREAS, the North Fork Service District (the District) has garbage facilities and has obtained waste removal contracts and facilities/equipment for the use and benefit of the residents and commercial properties of the District, and

WHEREAS, the Board of Trustees (the Board) previously established and amended monthly service charges for the delivery of garbage services to the users thereof, and

WHEREAS, the Board has determined it is necessary and in the interest of efficient operations, and upon public notice and hearing thereon, that the service charges heretofore established and imposed be changed as hereinafter set forth, and

WHEREAS, the Board is empowered under Title 17D-1-106 of the Utah Code to impose and collect fees and charges for all purposes of the Special Service District,

NOW, THEREFORE, the Board of Trustees of North Fork Special Service District RESOLVES as follows:

Sec. 1. It is hereby imposed for collection from all garbage users of the District facilities monthly service charges at the monthly rates set forth below:

The monthly cost per residential garbage disposal fees will increase from \$10.15 per month to \$10.91 per month. Commercial accounts will be charged 10 times the rate of residential accounts.


Sec. 2. The service charges established and imposed in Section 1 hereof shall take effect on November 1, 2025. The service charges shall be due and collected by the District when billed at the end of that month and each month thereafter on a continuing basis until repealed or changed by a subsequent action of the Board. Any outstanding fees prior to or as of this effective date shall remain due and payable, even after the effective date of this resolution.

Sec. 3. All other District policies and provisions not amended, changed, or affected hereby shall remain the same and in full force and effect.

Sec. 4. This Garbage Rate Resolution #2025-05 shall take effect October 9, 2025 upon its approval and adoption by the Board and without the publication or posting thereof.
