- a. Central Jordan River Reconnect Master Plan Update: Brandon Biederman, Associate Principal and Project Manager with the consulting team from PORT, will present an update of the ongoing Master Plan of the Central Jordan River Reconnect project (https://www.centraljordanreconnect.com). This project is developing a plan and implementation strategies for a proposed Jordan River regional park from 5400 South to Highway 201 in the central Salt Lake Valley. They will review initial ideas and recommendations that have emerged from public engagement, investigation and research, and are requesting feedback and guidance from the Committee. Angelo Calacino and Daniel Sonntag, park planners with Salt Lake County Parks & Recreation, will also participate to introduce and answer questions about the Master Plan.
- b. <u>Public Safety Discussion & Working Group</u>: This is a follow up discussion and request from the Jordan River Commission Governing Board to provide technical support and recommendations to address increasing public safety concerns, from the proliferation of electric and other motorized mobility vehicles and devices on the Jordan River Trail, to speed and congestion, creating risks and injuries among diverse users of the Jordan River Trail (see https://www.fox13now.com/news/driven-to-change/woman-hit-by-e-bike-speaks-out-as-officials-see-increase-in-accidents).

Through the Jordan River Commission's role in regional cooperation the Governing Board recommends the formation of a working group to coordinate approaches and best practices for public safety in some of the following areas:

- 2) Speed limits
- 3) Trail widths
- 4) Blind corners
- 5) Wayfinding and location
