AgVIP Updates



- New northern UT AgVIP/soil health planner - Nick Reithel
- Submitted building block request for \$1 million ongoing funding this next legislative session
- AgVIP/Soil Health promotional video coming soon!
- Contract obligation is complete: \$1,512,680 enrolling 45,466 acres
- Finishing site visits this month, plans will be completed and signed by producers by early December
- Plan implementation will begin during 2026 crop year

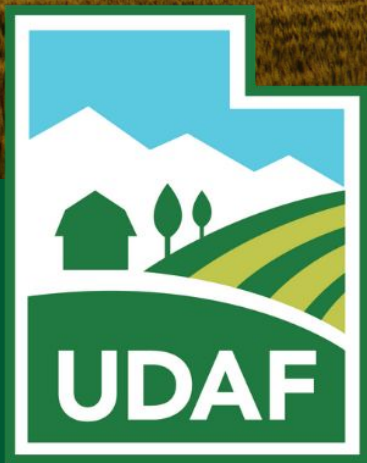

R64-6 AgVIP Rule Change



- Updating rule to streamline, remove unnecessary language, align with statutory authority
- Changes are for clarity and alignment, NOT to impact core mission or requirements
- Will be amended via a “repeal and reenact” process (similar to amendment process)
- Review highlighted main changes
