Makayla Pippy and Tanna Lee Strelbel are declared elected to the Tabiona Town Council.

The election is canceled because the number of candidates for the Tabiona Town Mayor and City Council is equal to the number of at-large positions to be filled and the filing period for a write-in candidate has passed (Utah State Code 20A-9-601). This action is taken pursuant to Utah State Code 20A-1-206.

A RESOLUTION TO CANCEL TABIONA TOWN'S
2025 MUNICIPAL ELECTION.

Whereas, the Town of Tabiona City Council as the duly elected legislative body of the City of Tabiona hereby wish to assert its authority granted under Utah State Code 20A-I-206 to cancel a local election if:

All municipal offices are elected at-large,

The number of municipal officer candidates does not exceed the number of open at-large municipal offices for which the candidates have filed,

Each municipal officer candidate is unopposed, and there are no other municipal ballot propositions.

Town of Tabiona Town Council does hereby declare that all of the above conditions have been met, and resolves to cancel the municipal election scheduled for November 4, 2025. This declaration is not later than 20 days before the day of the scheduled election as required by statute.

Town of Tabiona Town Council does hereby certify that Terry Hughes, Makayla Pippy and Tanna Lee Strebler, having lawfully filed as an unopposed write-in candidate for the 3 seats of the Town of Tabiona Town Council to be elected on November 4, 2025, are elected to office for a 4 year term to begin January 2026.

Further, proper notice of the cancellation of the election shall be given as required by UCA 20A-1-206(2).
