SUBJECT: Service Application and Privacy Policy

**Background**

The District is responsible for managing the billing and collection of Storm Water and Garbage utility fees for the city. It collects information from account holders and maintains a system that stores this data.

On March 24, 2022, the Utah Consumer Privacy Act (UCPA) was signed into law. This law governs businesses that collect and process personal data from Utah residents. Traditionally, the District has shared this personal data with the city as needed. However, following the enactment of this law, the District can no longer share this information without modifying its policy and updating the service application.

We have revised the service application to include the necessary language that allows us to legally share the collected data with West Haven City. Additionally, we have added sections for location and property characteristics to gather essential information for future uses.

Recommendation

The District Recorder and the District Attorney have updated the application to include the required information.

Staff recommends that the Board approve Resolution 13-2025, which would adopt the amended service application. This resolution will facilitate data sharing with West Haven City and enable the collection of additional information regarding the properties being serviced.

RESOLUTION NO. 13-2025

**A RESOLUTION OF THE WEST HAVEN SPECIAL SERVICE DISTRICT AMENDING
AND APPROVING AND ADOPTING APPLICATION FOR SERVICE AND
ADDENDUM A; AND PROVIDING FOR AN EFFECTIVE DATE.**

Section 1. Recitals:

WHEREAS, West Haven Special Service District (“District”) is a quasi-municipal corporation duly organized and existing under the laws of the State of Utah; and

WHEREAS, the District finds that certain sections of Utah Code Annotated 1953, as amended, authorizes public bodies, including the District, to exercise all administrative and legislative powers by resolution; and,

WHEREAS, the Board of Directors wishes to amend and approve the District’s application for service and addendum A for the public to use when applying for District and West Haven City services; and

WHEREAS, the Board of Directors finds that the public convenience and necessity, public safety, health and welfare is at issue in this matter; now

**THEREFORE, BE IT RESOLVED BY THE DISTRICT BOARD OF DIRECTORS
OF WEST HAVEN SPECIAL SERVICE DISTRICT as follows:**

Section 2. APPROVE AND ADOPT

That the District amends and approves and adopts the attached Application for Service and Addendum A that is attached as Exhibit A.

Section 3. Repealer of Conflicting Enactments:

All orders and resolutions regarding the changes herein enacted and adopted which have heretofore been adopted by the District, or parts thereof, which conflict with any of the provisions of this Resolution, are, for such conflict, repealed, except this repeal shall not be construed to revive any act, order or resolution, or part thereof, heretofore repealed.

Section 4. Prior Resolutions:

The body and substance of any prior Resolutions, together with their specific provisions, where not otherwise in conflict with this Resolution, are reaffirmed and readopted.

Section 5. Savings Clause:

If any provision of this Resolution shall be held or deemed to be or shall be invalid, inoperative, or unenforceable for any reason, such reason shall not render any other provision or provisions hereof invalid, inoperative, or unenforceable to any extent whatever, this Resolution being deemed to be the separate independent and severable act of the District Board of Directors of West Haven Special Service District.

Section 6. Date of Effect:

This Resolution, and the changes contemplated, shall become effective on the ____ day of October 2025, and after publication or posting as required by law.

1. To pay all connection, impact, and related fees (for a new connection) or the required transfer fee (for an existing home) and the service fees provided by the City and by the District for sewer and other applicable services.
2. To pay the service charges for sewer and other applicable utility services provided by the District and the City.
3. If a person, partnership, firm, or corporation other than the undersigned, occupies or is a tenant of the Premises, as an inducement to the City to provide services and to the District to provide sewer services to the Premises; the undersigned agrees to pay for all sewage and other applicable services provided to said premises.
4. In the event of payment failure, applicable services and other charges, the City and the District shall have the right to pursue further collection efforts and will do so by written notice of the City's and/or the District's intention, which may also include removal of the garbage receptacle. For residents on West Haven water, this may include disconnection of the culinary water service.
5. It shall be the property owner's responsibility, particularly if the owner is not the occupant of the Premises, to ensure that occupant receives all copies of any notices either mailed or delivered to the Premises, even if the billing address is different from the Premises. It is the responsibility of the property owner or occupant of the Premises, to inquire of the City and the District concerning such matters and to monitor bills and notices sent or delivered to the Premises.
6. That the City and District may cause a lien to be placed against the Premises for unpaid service fees and charges to the extent and in the manner allowed by law.
7. A finance charge of 1½ % per month (annual percentage rate 18%) of the unpaid balance will be added monthly. Should collection become necessary, the responsible party agrees to pay all collection costs and a collection fee of up to 40% and all legal fees of collection, with or without suit, including attorney fees and court costs.
8. I acknowledge by signing this application, the information I have provided will be shared with both West Haven City and West Haven Special Service District.
9. That the undersigned applicant is either the property owner or the duly appointed agent of the owner and is authorized to make this application binding against the Premises and that the purpose for which such service connection(s) will be used is:
