The board talks about adjusting the hours for the complex worker if a lawn care company takes over mowing and maintenance of the fields. The board asks about finding out what the cost could be for hiring a professional lawn care service for the complex. Derek Labrum brings up the idea of expanding one of the complex fields to accommodate Babe Ruth baseball.

Shawnee Snow informs the board that field one at the complex can not be expanded to accommodate a Babe Ruth field. Shawnee Snow brings up the idea of building a Babe Ruth size field on county property next to the complex. Derek Labrum talks about seeing what the cost of making a field would be. Jordan talks about the cost that would come with creating and maintaining another field at the complex. The board discusses looking into recreation grants and exploring the idea of creating a Babe Ruth field. They also discuss the need for a Babe Ruth field in the county.
