2. Office of Professional Licensure Review Sunrise Requirements

Jeff Shumway, Director, Office of Professional Licensure Review (OPLR), gave a presentation regarding the requirement that a legislator submit an application for sunrise review to the Office of Professional Licensure Review before the legislator introduces legislation.

The committee discussed possible statutory changes based on recommendations made by OPLR and asked questions of Jeff Shumway.

MOTION: Rep. Kyle moved to add language that repeals the provision requiring legislators to submit a sunrise review application to OPLR prior to introducing legislation that would regulate a previously unregulated profession.

SUBSTITUTE MOTION: Sen. Sandall moved to change the language to require a standing committee to consider any recommendations made by OPLR when reviewing legislation that would regulate a previously unregulated profession. The substitute motion passed with a vote of 9 - 4 - 7.
