Earl Taylor Councilman called the City Council meeting to order at 7:00 pm. led the pledge of allegiance and Jon Maxwell offered the opening prayer.

Approval of City Council September 10, 2025, was motioned by **Jon Maxwell. Randy Christiansen** seconded. Motion carried 3 to 0.

Approval of City Council September 24, 2025, was motioned by **Jon Maxwell. Randy Christiansen** seconded. **Kevin Mickelsen** seconded. Motion carried 3 to 1.

Approval of Bills Submitted for Payment was motioned by **Jon Maxwell. Kevin Mickelsen** seconded. Motion carried 3 to 0.

Visitors:

Jeff Brown-Executive Director Food Bank of Central Utah, addressed City Council seeking financial assistance. **Brown** explained that the food bank roughly serves 30 families from Sevier County. Approximately 2% of those served come from the Salina area. Brown stated the food bank urgently needs a large industrial freezer to expand storage capacity. Acknowledging that the ongoing government shutdown may increase demand, he asked the city to consider contributing \$5,000.00 though he said, "any amount would help." City Council agreed to help but would like to review the donation budget before committing funds and would get back with Mr. Brown. Brown also updated City Council on emergency medical services. He noted expanded paramedic training programs and participation in nation wide trial that places blood supplies in ambulances and

improving emergency response time. Police Chief Al Taylor praised the EMS teams.

Kathleen Green- sponsored trophy for Blackhawk Arena event Green asked City Council to sponsor a trophy in the amount of around \$450.00 for an upcoming barrel race to be held at the Blackhawk Arena November 21-23, 2025. Proceeds from the event will benefit the local FFA chapter, and students will help sell tickets and prepare for the competition. City Council will check the donation budget and reach out to Mrs. Green. **Jon Maxwell** personally offered to cover any remaining trophy cost if Salina City falls short.

\$606.32 allowing the fire department to choose the vendor. **Kevin Mickelsen** seconded. Motion carried 3 to 0.


Randy Christiansen:
