- Should look at a new auditor for 2026 (Squire firm has changed which auditor we have each audit, typically visits in August and delivers by November 1 deadline.)

School performance (15 minutes)

- Director's report
 - 14 ITR = Intent to Return
 - SLT = school land trust plan progress
 - Acadience reading and Rise math
 - Meet every 6 weeks for data to evaluate each grade and ensure they are where they need to be
 - Reveal Math students liking seeing pie chart growth
 - Equity & Grading professional learning: approach was to be a student with the facilitator and be comfortable where you are at, allowing us to build a foundation. It was complimentary of PCBL initiative
 - Very hopeful, long process, though the training was effective based on teacher feedback.
 - Crescendo coach will meet with individual teachers throughout the year.
 - Competency based grading: Proficiency scale to grade equitably
 - H2 Leadership working with Kindergarten and 5th grade faculty
 - ESI = Emergency Safety: restraint or seclusion (Will report once state report completed.)
 - 2 incidents this year so far. Debrief was very valuable.
 - Working with Blind Mule to get data for a behavior intervention plan
 - o 2 cohorts ended for faculty: Change management cohort was a favorite
