RESOLUTION No. 2025-36

A RESOLUTION APPOINTING OFFICERS OF THE CENTRAL WASATCH COMMISSION

WHEREAS, the Central Wasatch Commission (the “CWC”) is an interlocal entity created effective 29 June 2017 pursuant to the “Central Wasatch Commission Interlocal Agreement” dated 30 May 2017 (as amended, the “ILA”) among Salt Lake County, Salt Lake City, Sandy City and the city of Cottonwood Heights as the CWC’s initial members (“*Members*”); and

WHEREAS, since its formation, additional governmental entities have become Members of the CWC; and

WHEREAS, the governing body of the CWC is its board of commissioners (the “*Board*”); and

WHEREAS, Section V(C) of the ILA provides that bi-annually the Board shall elect from among its members a Chair, a Co-Chair, a Secretary and a Treasurer; and

WHEREAS, the CWC’s bylaws provide that such election typically shall occur at a January meeting of the Board; and

WHEREAS, the Board met in regular meeting on 31 October 2025 to consider, among other things, electing the following to serve as the CWC’s officers from 1 January 2026 until the Board’s January 2028 meeting or until each officer’s successor is elected and qualified:

WHEREAS, after careful consideration, the Board has determined that it is in the best interest of the CWC and its constituents to so act;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Central Wasatch Commission that the foregoing individuals are hereby elected to serve in the offices specified above from 1 January 2026 until the Board’s January 2028 meeting or until each officer’s successor is elected and qualified.

This Resolution, assigned no. 2025-36, shall take effect immediately upon passage as provided herein.
