1. Recognitions

President Johnson expressed his gratitude to the Board for their commitment and dedication to their responsibilities.

2. Public Comment

Ryan Le, parent of students in the district, began by offering condolences to President Johnson on the passing of his father. He expressed his concern regarding the lack of transparency surrounding the December 2024 mid-year stipend. He pointed out that the stipend was discussed in a closed session on October 15, 2024 and then approved on October 22, 2024, without clear public disclosure of the amount or scope of the expenditure. He emphasized support for educator compensation, but raised concerns about the process lacking transparency. He urged the Board to set a

state-wide example for transparent governance.

Business Administrator Todd Hess presented the board budget reports through the end of August. He noted that since the fiscal year had just begun, limited spending had occurred, and teacher payroll had not yet started. Overall, he reported the budget is in line with where we should be. He pointed out the 46% of the general district administration budget appeared spent. He explained that this is due to insurance premiums being paid early in the year, which make up a significant portion of that budget. These costs will be reallocated to different functions later in the year, as is standard practice.

5. Superintendent's Report

Superintendent Hatch reported on TeachFX. He reviewed data from Iron County School District teachers who have used the tool. They reported drastic improvements in areas like:

- Opportunities to respond
- Specific praise
- Use of open-ended questions
- Encouraging students to explain their thinking

Superintendent Hatch indicated he has never seen a professional development initiative have such a powerful

impact on teaching. TeachFX is not mandated, just made available to teachers who would like to utilize it. Schools have embedded it into their goals asking teachers to try it at least once. Mr. Taylor and Mr. Eddy raised points about potential risks, especially regarding how actions or tools could negatively impact teachers or students. Superintendent Hatch agreed that safeguards are important and even though he is confident that misuse won't occur, he was open to creating a policy that ensures protections are in place.

6. Board Member Report

Mrs. Christiansen provided an update from Canyon Creek Services. They have partnered with schools in the district to deliver 23 educational events focused on healthy relationships, consent, boundaries, and bystander intervention. These programs have been shown to reduce sexual harassment by up to 30% and reports of sexual violence by 57% in schools. They plan to expand classroom-based prevention education and staff trainings.

Mrs. Christiansen thanked Ryan Le for his comments and praised his support for ELA, transparency, and fair teacher pay. She also addressed recent negativity in the community, especially on social media, and emphasized the importance of civility and respectful dialogue. Lastly, Mrs. Christiansen highlighted impressive gains in kindergarten literacy due to the science of reading approach, with proficiency rising to around 70-80%. She credited teacher training and emphasized the importance of maintaining the 120-minute daily reading block as a non-negotiable part of classroom instruction.

Mrs. Hill praised the district's implementation of the Science of Reading, noting that building leaders were trained last year after it was found they hadn't previously understood its importance. The results were impressive with end of year literacy scores showing kindergarten at 70% proficiency, with first and second grades near 70%, and third grade over 71%. She mentioned a teacher at North Elementary who brought all her second grade students, some starting at pre-primer

level, up to grade level. She emphasized that early reading success sets students up for long-term achievement and highlighted the strong connection between literacy and life outcomes. She also reported that regular progress meetings are planned moving forward.
