Ballots will be mailed October 14.

If you have any issues with voting a ballot by mail, please contact the office for assistance.

Election day to be counted.**

You must be a US Citizen; a resident for at least 30 days before Election Day; and 18 years of age on or before the General Election.

There are several **DROP BOX** locations throughout the County: Ballard City Offices, Naples City Offices, Vernal City Offices, the County Bldg, and drive-thru at the Library.

EARLY VOTE will be in the Clerk-Auditor's Office during normal business hours,
**M-F, 8 am to 5 pm,
October 21 thru October 31.**

You must bring your ID and proof of residency if you have moved.

There is only one **VOTE CENTER** open on Election Day: **Tuesday, November 4, 2025** in the **Commission Chambers** of the Uintah County Building, 147 East Main; polls are open from **7 am to 8 pm**.

**Ballots must be received by 8 pm on
Election Night in order to be counted.**

The Election will be **AUDITED November 12 at 2 pm** in the Clerk-Auditor's Office.

The **CANVASS** of the Election will be conducted by the individual Cities and Districts on **November 17th**. Please reach out to them for more information, times and locations.
